**What are the rates?**

Registration: \$50 (non-refundable)

**Do I have to pick my days in advance?**

Yes, when you register you will choose the days of the week you'll need care.

No “swapping” days. If school is closed or your child is absent on their regularly scheduled day, you may not make up that day later in the week. Please follow the regular schedule you have selected for your child.

**Can I change my days?**

Yes, please complete our [schedule update form](#). A change fee of \$35 will apply and you’ll need to make the change by 12:00 pm on Wednesday for the change to take effect the following Monday. Changes are approved based on availability.

**Is there a fee to make changes?**

Yes, there is a \$35 administrative fee per child, per request for changes.

**If 5 days is (\$\$\$) why am I paying more than the daily rate for fewer days?**

We know our parents value flexibility and that’s why we are offering more options this year. With this, there are some increased administrative costs associated with expanding our flexible options. Our pricing covers those increased costs.

**What is the “drop-in” option?**

We are now allowing a “drop in” for parents/guardians that are in need of a day, if space is available, in either Before Care or After Care. The program starts **Oct. 1st**. This option is available for those who are both currently enrolled in our programs and those who are not.

**If I am not currently enrolled in SACC, how do I register for the “Drop-in Program?”**

Prior to August 29, register via ActiveNet and register for the "GB Drop-in Program" and pay the \$50 non-refundable registration fee. This places you on the list of available participants who can use the drop in program. Complete the [schedule update form](#) at least 48 business hours in advance when you would like to participate. If space is available, your request will be granted, and you will be notified via email.

After August 29, call our Remote Welcome Center at 973-758-9039 first to register for the program and then complete the schedule update form to request days.

**If I am currently enrolled in SACC, how do I register for the "Drop-in Program?"**

If space permits, there is a "drop in" option for those parents/guardians that need an extra day during a given week.

Complete the [schedule update form](#) at least 48 business hours in advance when you would like to participate. If space is available, your request will be granted, and you will be notified via email.

**If there is a half day on a day I am not registered, can I send my child until regular school dismissal time?**

If space permits, there is a "drop in" option for those parents that need an extra day during a given week. Complete the [schedule update form](#) at least 48 business hours in advance when you would like to participate. If space is available, your request will be granted, and you will be notified via email.

**If my child is out on a registered day, can we make it up on another day?**

No. Unfortunately, we cannot accommodate make-up days.

**I registered my child (on registration day) for 3 days and realized I now need 5, how do I add the other days at the 5 day a week fee?**

**I receive a state child subsidy, can I choose fewer than 5 days?**

At this time, all families receiving a subsidy need to register for 5 days.

**Will my Financial Aid award be reduced if I register for less than 5 days/week?**

No, your award is a percentage off of your fee, therefore, you'll receive the same percentage award for the lower rate.
